

## *The Response of Faith, Love and Hope*

### Introduction

- A. Having discussed how God Himself – as a Person – is the most “real” in all of reality, we now must ask ourselves how we “should” respond to Him.
- B. The way we intuitively – without hesitation – respond to natural law may set a pattern for how we should respond to God. Let’s discuss that principle.

### I. Some Truths Related to Natural Law and How We Utilize Them.

- A. God has created such laws as a resource for His glory and our well being.
- B. Learning of these laws and implementing them we reveal His wisdom, power and glory as well and bringing great benefit to ourselves. We “work” His garden, Gen 2:15.

### II. Some Truths Related to Spiritual Reality and How We Are To Respond.

- A. The emphasis today is on the reality of God as a Person – how do we respond to Him as reality – similar and yet in a different way – from how we respond to natural law?
- B. The Bible speaks of “*living worthy* (in harmony with) of *God*,” (1 Thess. 2:12). See also Eph. 4:1; Phil.1:27; and Col. 1:10. Is this one way we respond to natural law?

### III. Every Practice of True Obedience is an Expression of Love for God.

*“If you love me you will obey what I command”* John 14:15
